**BASIC School Bus Driver Instructor Course**  
**scheduled for June 26 - 28, 2009**

A **Basic School Bus Driver Instructor Course** will be held on **Friday, June 26 through Sunday, June 28, 2009**, at **The Sturbridge Host Hotel**, 366 Main Street, Sturbridge, MA. **Directions:** Take the Mass Pike (Interstate 90) to Exit 9, Route 20 West. From the South, take either Interstate 84 or Route 131 to Route 20 West. The hotel is located less than one-quarter mile from the first set of traffic lights, on the shore of Cedar Lake. Hotel driveway is approximately one mile down on the right, between McDonalds and Burger King.

To attend the course, **the only requirement is applicants must be licensed school bus drivers for at least two full years.** Enclosed is information about the course and hotel arrangements, along with a cut-off registration form to be used to enroll your applicant(s) for the course. If you believe that you will require the certification of an instructor, you should enroll individuals in this course as soon as possible, as class size is limited.

As a result of several suggestions, this course will include a session on preparing drivers for the New Restricted School Bus Driver Certificate. Instructor candidates enrolled in this course will therefore "bring home" valuable information to share with colleagues. Practice teaching presentations and instructional techniques learned will help to improve the confidence of future license applicants and to improve the percentage of applicants successfully passing the test on the first try.

The hours of the instructor course are Friday, with registration from 5:30 p.m. to 6:00 p.m., and class from 6:00 p.m. to approximately 9:30 p.m., and Saturday and Sunday, 7:30 a.m. to 4:00 p.m. Students must be present at all sessions to be considered for certification.

There have been many changes in laws and regulations affecting school transportation and the media have carried extensive articles about greater enforcement of school transportation laws. If you have any concerns about the nature of your training programs or general operations, this would be a good time to send your school bus drivers to this course.

Although it is not required, it is strongly recommended that attendees stay at The Sturbridge Host Hotel. We have arranged a block of rooms at a reduced rate for attendees. Hotel room rates and information are enclosed. Staying at the hotel allows the enrollee time to concentrate on the course materials and prepare for the practice teaching presentation. In addition, it provides maximum opportunity for sharing techniques and ideas with other students.

We have quite a few drivers waiting to enroll in the instructor course. Therefore, as class size is strictly limited, early registration is encouraged. Recent enforcement campaigns by the Registry of Motor Vehicles and Department of Public Utilities have called attention to the importance of proper training programs resulting in increased demand for instructor training. The course begins **promptly** at 6:00 p.m. on Friday. Enrollees must complete the brief on-site registration process anytime between 5:30 and 6:00 p.m., prior to the start of the first session. The course will end promptly at 4:00 p.m. on Sunday.

In order to be certified as having completed the course, students must be present for all sessions. The critical activity of the course is the presentation of a practice teaching lesson on Sunday morning, which will demonstrate the instructional skills and techniques presented in Saturday's sessions. There is no written examination involved in the course. The only materials to be supplied by the student are notebooks for notetaking and writing tools such as pens and pencils.
